ELECTRICAL ITEMS: ANY FAULTY ITEMS SHOULD BE MARKED AS FAULTY ON DELIVERY. Under the Low Voltage Electrical Equipment (Safety) Regulations 1989, electrical items submitted for auction must either be sold as tested by a suitably qualified electrician or sold as scrap and clearly labelled as such with the lead removed. Genuine antique and collectors' items can be sold "for display purposes only" and the leads and plugs removed. A Qualified Electrician will test all electrical items entered prior to the auction and a charge of £2.40 incl. V.A.T. will be made for each item, this being deductible from the sale proceeds.

UPHOLSTERED ITEMS: Under the Furniture and Furnishings (Fire) (Safety) Regulations 1988, all second-hand furniture which is offered for sale must meet the full fire resistance requirements & must have a permanent label attached. The only exemption from these Regulations is for furniture made before 1950. We will therefore be unable to offer any upholstered furniture made after 1950 that does not have the necessary fire regulations label with batch number attached.

VEHICLES: Under the Road Traffic Act any vehicles which are to be offered for sale should be insured with at least Third-Party Insurance.
